## **Summit Christian Academy Tuition Assistance 2022-2023**

Tuition Assistance Application is CONFIDENTIAL and will be seen ONLY by the Tuition Assistance Committee. The award amount depends on number of families who applied for the tuition assistance and the amount of allocated tuition assistance fund. The application window for current families will close on March 31<sup>st</sup>, 2022. For new families, tuition assistance is available as funds permit. The tuition assistance cannot exceed 20% per family and 25% in total discounts. The application fee is \$25 and nonrefundable.



Each family is required to participate in working out additional service hours based on their awarded tuition assistance percentage.

## **Guidelines:**

- 1. A family must be accepted at Summit Christian Academy.
- 2. Request and fill out the application completely.
- 3. Prepare all needed documentation for the INTERVIEW (tax documents, bank statements, pay stubs for the last two months).
- 4. Student(s) must be in good conduct and maintain a GPA of 2.0 or higher in the preceding semester.
- 5. Current families' tuition assistance window will close March 31st, 2022.
- 6. The family interview will be scheduled around the first week of April 2022; the SCA office will notify the family in advance.
- 7. The tuition assistance will be awarded and included in the issued Enrollment Confirmation by June 1<sup>st</sup>, 2022
