



FAMILY COMMITMENT TO CHRISTIAN EDUCATION AT SCA

In accordance with our family decision to enroll our child(ren) at Summit Christian Academy, we hereby agree to accept and promote the following responsibilities.

PLEASE INITIAL

Christian Lifestyle: We understand that the standards of Summit Christian Academy require both parents and students to conduct themselves in a manner that brings glory to God. We will uphold the spiritual emphasis of SCA and model the Christian lifestyle in our home and our spiritual life. _____

Christian Conduct: We will faithfully support the school through our prayers and positive attitude. We will share any complaints, questions or negative comments with ONLY the people involved (administration or faculty), and NOT around our child(ren) or other parents/families. _____

Academic Standards: We will support the high academic standards of the school by encouraging and supporting good study habits and by giving our child(ren) the appropriate amount of help to complete homework, memorization, and projects on time. _____

School Events/ Attendance: We understand that parents' failure to comply with the established SCA policies and discipline, and lacking parental commitment (including but not limited to bringing children to required school performances, attending school events, participating in school fundraisers, and financial obligations) will forfeit the student's privilege to attend SCA. _____

Finances: We agree to meet all financial obligations promptly. We understand that our failure as parents' to comply with SCA financial policies and obligations will forfeit our child(ren)'s privilege to attend SCA. We understand that SCA contracts with teachers and staff for the academic school year regardless of enrollment changes. The annual and tuition fees are non-refundable and due in full. The annual and tuition fees will apply for any withdrawal reasons, including expulsion, and school records will be on hold until all accounts are settled and materials returned. _____

Liability: We release SCA staff from all liability, except negligence, while our child(ren) are under school care and responsibility. We understand that we need to have our own medical and major accident insurance to cover any emergency situation during school hours at the school rented facility and school related events. We give permission to the school authorities, in case of emergency, to obtain medical treatment for our child(ren) in our absence. We will keep the school informed in writing of any changes in health or medication which may affect our child(ren) in school. We take the responsibility to pay for damage to the school rented property caused by our child(ren). _____

Service Hours: We understand that in order to keep SCA's cost to a minimum, each family is required to complete 30 service hours per family. 15 hrs should be served during 1st semester and another 15 hrs during 2nd semester. In case of service hours' incompleteness, we agree to pay off the remaining hours at \$12.50 per hour. _____

Annual Auction Participation: We agree to participate in the annual school auction by (1) donating items and volunteering on the auction team OR by (2) paying the opt-out fee \$100 per family. _____

Changes: We understand that it is our responsibility to contact the SCA office regarding any changes to our contact information (phone/email and/or address). _____
